Omega undertook a project located in London in Sunbury on Thames. The task was to carry out the safe removal and disposal of asbestos in various forms from various locations. The value of the project is valued at approximately £100,000 and had an estimated duration of 6 weeks.

The scope of work carried out includes; the safe removal and disposal of AIB cavity closers containing Amosite.

General Works

All works are proceeding in a systematic manner to eliminate potential risks. The floors have been laid out in a grid like pattern delineated by columns. Areas for work will be identified and briefed to operatives on a daily basis and will seek to remove materials in the following order:

- Materials and debris creating hazards for working (e.g. fallen or hanging ceilings, trip hazards)
- General ceilings and fixtures at height;
- Asbestos materials;
- Floor coverings and other low level materials;
- Waste removal.

A large quantity of waste must be removed from the work area on a daily basis to facilitate the smooth running of the programme. To enable the easy movement of waste materials, reduce the number of skips and traffic movements around the site.

The project is expected to be completed on the 18th November. This is looking promising as a result of the hard work and commitment that Omega personnel offer on a daily basis.

Omega has recently began a project located in Newbury, on a large warehouse containing asbestos insulation boards within the ceilings, doors, walls, and external cladding panels.

Our involvement with the Contract:

- Quantify and programme the works with due allowance for other trades and site conditions.
- Provide expert guidance to the CDM co-ordinator as to the methods of working that will be adopted in order to successfully and safely complete the project.
- Liaise all health and safety issues with everyone operating on the site and conduct regular meetings to inform personnel of any changes.
- Design a method of working that is appropriate in order to remove or encapsulate the waste in order to prevent risk to occupiers of the structure, other workers on site, Omega employees or anyone else who may come into contact with the risk.
- Provide risk assessments and COSHH sheets tailored for the project
- Design and provide specific encapsulation environments in order to provide negative pressure enclosure containment to prevent asbestos contamination during the course of the works.
- Provide suitably skilled and trained management and directly employed labour to undertake the contract works at sufficient resource levels to complete the project within the contract programme
- Provide waste removal for contaminated waste to our own licensed waste transfer station.
